Introduction

Social, Personal and Health Education, as part of the curriculum supports the personal development, health and wellbeing of our students. It contributes and complements the existing Pastoral and Academic Programmes being offered in our school.

Social, Personal and Health Education (SPHE) provides students with a unique opportunity to develop the skills and competence to learn about themselves and to care for themselves and others and to make informed decisions about their health, personal lives, and social development. All these decisions must be made in the context of the wider community.

With such support, students may be enabled to participate as active and responsible adults in the personal and social dimensions of society and to make responsible decisions that respect their own dignity and the dignity of others.

Parents/guardians have the primary responsibility for the social, personal and health development of their children. Their acknowledgement and support for the SPHE programme is necessary for its effective implementation. Should parents/guardians wish, copies of the programme are available to view, within the school by arrangement with the Principal or Deputy Principal.

Rationale

- To enable the students to develop personal and social skills.
- To promote self-esteem and self-confidence.
- To enable the students to develop a framework for responsible decision making.
- To provide opportunities for reflection and discussion.
- To promote physical, mental and emotional health and wellbeing.

Relationship to Mission Statement

As enshrined in our mission statement we aim to provide a holistic education in cooperation with teachers, students, parents/guardians, management and the community.

This supportive school environment is essential for SPHE to be effective. Every teacher and staff member continues to offer opportunities for enhancing the personal and social development of the student.

This Policy document applies to students and their parents/guardians in 1st year, 2nd year and 3rd year. S.P.H.E. is mandatory for all classes in Junior Cycle under Department of Education & Science Guidelines.





SPHE in the Classroom

- Department of Education Circular H22/00 states that the recommended time allocation is the equivalent of one class period, per week to all students at Junior Cert level.
- Through participation in the SPHE Programme the student will encounter a
 wide range of issues through a variety of learning experiences. These issues
 will be addressed in ten modules, each of which appears in each year of the
 three-year cycle. The emphasis will be on building skills, understanding,
 attitudes and values important in all these areas.

The ten modules are:

- Belonging and Integrating
- Self-management
- A sense of purpose
- Communication Skills
- Physical Health
- Friendships
- Relationships and Sexuality
- Emotional Health
- Influences and Decisions
- Substance Use
- Personal Safety
- The following subject areas i.e. P.E., Science, R.E., CSPE, Home Economics form cross curricular links with the SPHE Programme.
- Teaching Methodologies may include: Group work, role play, brainstorming, icebreakers, simulation, working in pairs, narrative expression, debating, project work, art work, multi-media materials, case studies, visiting speakers.
